3.According to the complaint, without paying the entire sale consideration, the proposed accused got the sale deed executed from the petitioner herein and thereby the proposed accused has cheated the petitioner to an extent of Rs.17,50,000/-. So saying, the complaint has been lodged.

Side) would submit that preliminary enquiry has been conducted, wherein, the finding is that the petitioner has been cheated to the extent of Rs.17,50,000/- and therefore, the complaint has been forwarded to the Assistant Commissioner, Kottai Division, Trichy for further enquiry.
