ORDER

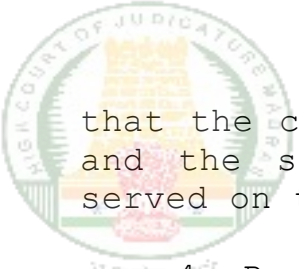
This petition has been filed for a direction to the 2nd respondent to register a case on the basis of the complaint of the petitioner, dated 14.02.2016 in accordance with law.

2.Heard the learned counsel for the petitioner and the learned Government Advocate (Crl. Side) for the respondents.

3. According to the complaint, the petitioner has paid a sum of Rs.7,40,000/- out of the total sale consideration of Rs.9 lakhs. On such payment being made, an agreement of sale has been entered into between the petitioner and the accused persons. However, when the petitioner urged the accused persons to register the sale in favour of the petitioner on paying the balance amount, the accused persons threatened him to cancel the sale agreement.
