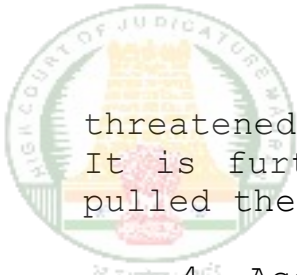

ORDER

It is a petition seeking a direction to the respondents to register the case on the complaint of the petitioner, dated 17.02.2016 and 07.04.2016 and to investigate and to file a final report.

2.Heard the learned counsel for the petitioner and the learned Government Advocate (Crl. Side) for the respondents.

3.According to the complaint, due to a civil dispute between the petitioner and the accused persons, the accused persons



threatened the petitioner and also abused her in filthy language. It is further averred in the complaint that the accused persons pulled the petitioner from the vehicle and ran away.

4. According to the learned Government Advocate (Crl. Side), petition enquiry is stated to be pending before the 3rd respondent.

4. In view of the above submission, the respondent is directed to expedite the enquiry and complete the same within a period of one month from the date of receipt of a copy of this order. During the course of enquiry, if any cognizable offence is made out, the respondent police shall take action in accordance with the law laid down by the Hon'ble Apex Court in **Lalitha Kumari vs. Govt. of U.P & others [2013 (4) Crimes 243 (SC)]**. In case of closure of the complaint, a copy of the closure report be furnished to the petitioner within a week of such closure. On receipt of the same, it is open to the petitioner to work out her remedy in the manner known to law.

With the above direction, this Criminal Original Petition is disposed of.
