The learned counsel for the petitioner and the learned Government Advocate(Crl.side) for R1 & learned counsel for R2 to R4 are presented.

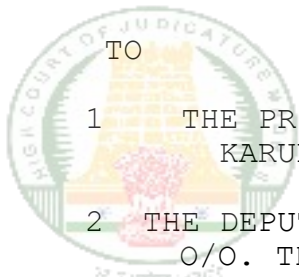
