3.The learned Government Advocate produced a letter sent by the Tahsildar, Madurai East, Madurai, to him stating that on enquiry, he came to know that the encroachment was removed and that the encroachers have also been directed not to encroach upon the said land again. The said statement is recorded.

4. In view of the above, nothing survives for adjudication in this Writ Petition. This Writ Petition is, therefore, dismissed. No costs.
