ORDER : The Court Made the following order :-

The petitioners, who apprehended arrest at the hands of the respondent Police for the alleged offences punishable under Sections 294(b), 498(A), 506(i) I.P.C., and Sections 3 and 4 of Dowry Prohibition Act, in Crime No. Not Known of 2015, on the file of the first respondent Police, seek anticipatory bail.

4. Today, when these criminal original petitions are taken up for hearing, the learned Government Advocate (Criminal Side) has submitted that the complaint lodged by the de facto complainant has been closed after conducting enquiry.

5. In view of the submission of the learned Government Advocate (Criminal Side), these criminal original petitions are closed.
