PRAYER: Criminal Original Petition filed under Section 482 of Cr.P.C. praying to direct the first respondent to instruct the 2nd respondent to register the First Information Report, on the basis of the petitioner's complaint, dated 26.05.2016.

ORDER

It is an application seeking a direction to the second respondent to register a case based on the complaint of the petitioner dated 26.05.2016.

2.Heard the learned counsel for the petitioner and the learned Government Advocate (Crl. Side) for the respondents.

3.The sum and substance of the complaint of the petitioner is that the proposed accused illegally trespassed into the land belonging to the Trust in which the petitioner is a Managing Trustee and constructed a private children park. As no case was registered on the said complaint, the petitioner has come up with this petition.

4.According to the learned Government Advocate (Crl. Side), petition enquiry is pending before the second respondent.



5. In view of the above submission, the second respondent is directed to expedite the enquiry and complete the same within a period of two weeks from the date of receipt of a copy of this order. During the course of enquiry, if any cognizable offence is made out, the second respondent police shall take action in accordance with the law laid down by the Hon'ble Apex Court in *Lalitha Kumari vs. Govt. of U.P & others [2013 (4) Crimes 243 (SC)]*. In case of closure of the complaint, a copy of the closure report be furnished to the petitioner within a week of such closure. On receipt of the same, it is open to the petitioner to work out her remedy in the manner known to law.

6. With the above direction, this Criminal Original Petition is disposed of.
