PRAYER: Criminal Original Petition filed under Section 482 of Cr.P.C. praying to direct the respondents particularly the second respondent to register the complaint of the petitioner dated 19.02.2015 and investigate the same in accordance with law and also file the final report.

ORDER

It is an application seeking a direction to the second respondent to register a case based on the complaint of the petitioner dated 19.02.2015.

2.Heard the learned counsel for the petitioner and the learned Government Advocate (Crl. Side) for the respondents.

3.The sum and substance of the complaint of the petitioner is that the proposed accused, who is the driver of a vehicle in which the petitioner travelled for business purpose, committed theft of a sum of Rs.5 lakhs from his suitcase. As no case was registered on the said complaint, the petitioner has come up with this petition.

4.According to the learned Government Advocate (Crl. Side), petition enquiry is pending in C.S.R.No.72 of 2015 before the second respondent.

5.In view of the above submission, the second respondent is directed to expedite the enquiry and complete the same within a period of two weeks from the date of receipt of a copy of this order. During the course of enquiry, if any cognizable offence is made out, the second respondent police shall take action in accordance with the law laid down by the Hon'ble Apex Court in **Lalitha Kumari vs. Govt. of U.P & others [2013 (4) Crimes 243 (SC)]**. In case of closure of the complaint, a copy of the closure report be furnished to the petitioner within a week of such closure. On receipt of the same, it is open to the petitioner to work out his remedy in the manner known to law.
