PRAYER: Criminal Original Petition filed under Section 482 of Cr.P.C. praying to direct the 2nd Respondent police to register a case in pursuant to the complaint dated 21.05.2016 given by the petitioner.

ORDER

It is an application seeking a direction to the second first respondent to register a case based on the complaint of the petitioner dated 21.05.2016.

2.Heard the learned counsel for the petitioner and the learned Government Advocate (Crl. Side) for the respondents.

3.The sum and substance of the complaint of the petitioner is that the proposed accused have received a sum of Rs.7,00,000/- from the petitioner, promising to repay the same within one year. But, they cheated the petitioner without paying the said amount and threatened him with deadly weapons. As there was no case registered, the petitioner has come up with this petition.

4.According to the learned Government Advocate (Crl. Side), petition enquiry is pending before the second respondent.

5.In view of the above submission, the second respondent is directed to expedite the enquiry and complete the same within a period of one month from the date of receipt of a copy of this order. During the course of enquiry, if any cognizable offence is made out, the second respondent police shall take action in accordance with the law laid down by the Hon'ble Apex Court in **Lalitha Kumari vs. Govt. of U.P & others [2013 (4) Crimes 243 (SC)]**. In case of closure of the complaint, a copy of the closure report be furnished to the petitioner within a week of such closure. On receipt of the same, it is open to the petitioner to work out his remedy in the manner known to law.



6. With the above direction, this Criminal Original Petition is disposed of.
