Petition filed under Section 482 of the Code of Criminal Procedure praying to direct the respondent to register the petitioner's complaint dated 19/03/2016 pending before the respondent police.

ORDER

It is an application seeking a direction to the respondents to register a case based on the complaint of the petitioner dated 19.03.2016.

2.Heard the learned counsel for the petitioner and the learned Government Advocate (Crl. Side) for the respondents.

3.The sum and substance of the complaint of the petitioner is that the proposed accused is the neighbor of the petitioner. The proposed accused deceived the petitioner's friend without paying a sum of Rs.39,000/-. On 16.03.2016, the petitioner's husband met the proposed accused and demanded the said amount on behalf of his friend. But the proposed accused in a drunken mood, attacked the petitioner's husband and thereby caused blood injuries all over his body. As there was no case registered, the petitioner has come up with this petition.

4.According to the learned Government Advocate (Crl. Side), petition enquiry is pending.



5. In view of the above submission, the second respondent is directed to expedite the enquiry and complete the same within a period of one month from the date of receipt of a copy of this order. During the course of enquiry, if any cognizable offence is made out, the second respondent police shall take action in accordance with the law laid down by the Hon'ble Apex Court in **Lalitha Kumari vs. Govt. of U.P & others [2013 (4) Crimes 243 (SC)]**. In case of closure of the complaint, a copy of the closure report be furnished to the petitioner within a week of such closure. On receipt of the same, it is open to the petitioner to work out her remedy in the manner known to law.

6. With the above direction, this Criminal Original Petition is disposed of.
