PRAYER: Criminal Original Petition has been filed under Section 482 of Cr.P.C., praying to direct the first respondent to instruct the second respondent to register the case on the basis of the petitioner's representation, dated 18.01.2016.

ORDER

It is an application seeking a direction to the second respondent to register a case based on the complaint of the petitioner dated 18.01.2016.

2.Heard the learned counsel for the petitioner and the learned Government Advocate (Crl. Side) for the respondents.

3.The sum and substance of the complaint of the petitioner is that the proposed accused collected a sum of Rs.1 lakh from the petitioner under the guise of making arrangement for getting assistance from the Central Government and swindled the assistance amount given by the Central Government. When the petitioner asked to repay the amount collected and also the assistance amount, the proposed accused threatened the petitioner. As no case was registered on the said complaint, he has come up with this petition.

4.According to the learned Government Advocate (Crl. Side),

petition enquiry is pending before the second respondent.

5. In view of the above submission, the second respondent is directed to expedite the enquiry and complete the same within a period of one month from the date of receipt of a copy of this order. During the course of enquiry, if any cognizable offence is made out, the second respondent police shall take action in accordance with the law laid down by the Hon'ble Apex Court in **Lalitha Kumari vs. Govt. of U.P & others [2013 (4) Crimes 243 (SC)]**. In case of closure of the complaint, a copy of the closure report be furnished to the petitioner within a week of such closure. On receipt of the same, it is open to the petitioner to work out her remedy in the manner known to law.

6. With the above direction, this Criminal Original Petition is disposed of.
