ORDER

The petitioner seeks for grant of Natham house site patta for the lands occupied by her at Natham Survey No.1683 (Old Natham Survey No.431/1) 1 of Manamadurai Village, Manamadurai Taluk, as per G.O(Pt) No.854, Revenue Department, dated 30.12.2006.

2.By claiming benefit under the said G.O and making a representation on 02.09.2014, the petitioner sought for the grant of patta.

3.The grievance of the petitioner is that the said request has not been considered so far. Therefore, without expressing any view on the merits of the claim made by the petitioner, I only direct the second respondent to consider the representation of the petitioner, dated 02.09.2014 and pass orders on the same on merits <https://hcmv.judges.gov.in/cases> with law, also by taking note of G.O(Pt) No.854, Revenue Department, dated 30.12.2006, within a period of eight weeks from the date of receipt of a copy of this order.



4. Accordingly, the Writ Petition is disposed of. No costs.
