Having regard to the limited scope of prayer sought for, the 2nd respondent is directed to consider the representation dated 07.06.2016 of the petitioner and take appropriate action in accordance with law, preferably within a period of one week from the date of receipt of a copy of this order in the light of the decision taken in the Peace Committee Meeting. It is for the respondent police to take action in accordance with law in case of any hindrance on the side of the respondents 3 to 6.
