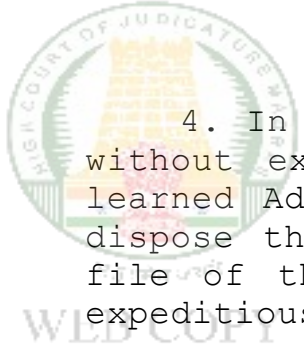

According to the petitioner, the petitioner has filed the petition in R.C.O.P.No.311 of 2016 on the file of the learned Additional District Munsif(Rent Controller), Madurai, on the ground of willful default, against the respondent/tenant and in the said petition, an exparte decree was passed on 03.11.2015. Thereafter, the petitioner has filed an application in E.P.No.23 of 2016 in R.C.O.P.No.311 of 2014 before the Additional District Munsif Court, Madurai Town. The aforesaid application has been adjourned from time to time without prejudice cause to the interest of the petitioner.
