2.The petitioner is the defendant in the suit. The respondent/plaintiff filed a suit in O.S.No.75 of 2011 before the file of the District Munsif, Madurai for injunction restraining the petitioner and his agent from interfering with his peaceful possession and enjoyment of the suit schedule property.

3.The petitioner filed written statement and also filed counter claim. The respondent filed a reply statement to the counter claim on 29.08.2016. The said suit was posted for framing issues and further adjudication. Subsequently, the issues were not framed and at the request of the respondent, the suit is posted for filing reply statement and the respondent is prolonging the matter. In the circumstances, the petitioner has come out with the present Civil Revision Petition.
