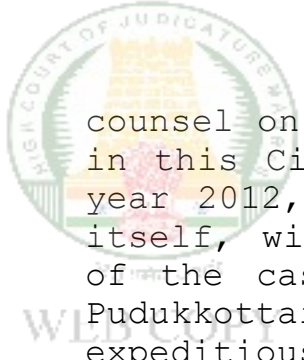
This Civil Revision Petition is filed, for early disposal of the suit in O.S.No.319 of 2012, on the file of the learned Subordinate Judge, Pudukkottai.

2. The petitioner is the plaintiff in O.S.No.319 of 2012 and the respondent is the defendant. The petitioner filed the suit for eviction against the respondent. The respondent is in occupation of the suit property, as a tenant and running a textile business. The respondent did not pay the rent from December, 2011. Now, the respondent shifted his textile business to other premises and kept the suit property lying vacant and did not hand over the vacant possession to the petitioner. In the circumstances, the respondent filed written statement on 10.04.2013. From that date onwards, it was adjourned on various occasions, without any reason. In the circumstances, he has come up with this present Civil Revision Petition for speedy disposal of the suit.
