The learned counsel for the 4th respondent/impleaded respondent brought to the notice of this Court that the main writ petition itself is only for seeking approval of the appointment of the post of the Headmistress. On the objection made by the 4th respondent, the appellate authority cancelled the approval and therefore, final order has been passed on the approval order on 17.06.2015. Challenging the said order, the very same petitioner filed a writ petition in W.P.No.19657 of 2015 before the Principal Bench of this Court and the same is pending. Therefore, the present writ petition has become infructuous.

4. Recording the submission of the 4th respondent to the effect that the writ petition has become infructuous, this writ petition is closed with liberty to the petitioner to agitate the matter in the pending writ petition in W.P.No.19657 of 2015 before the Principal Bench of this Court. No costs.
