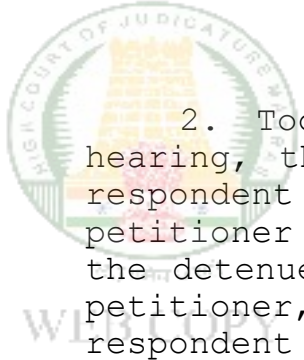

ORDER

(Order of the Court was made by **S.NAGAMUTHU, J.**)

The petitioner is the husband of one Mrs.Bhavani. According to him, marriage took place between him and Bhavani on 29.04.2016. But, according to the petitioner, she is illegally detained by the mother of the detainee, the 4th respondent herein.



2. Today, when the Habeas Corpus Petition is taken up for hearing, the detinue was produced by the third respondent. The 4th respondent has also made her appearance before this Court. The petitioner is also present along with his counsel. When we enquired the detinue, she has stated that she is not willing to go with the petitioner, but she would like to go only with her mother, the 4th respondent herein. She further submitted that she has not been illegally detained. When this was pointed out by the learned counsel for the petitioner, the petitioner stated that he would work out his remedy before the civil Court. The said statement is recorded.

3. Accordingly, this petition is dismissed, leaving it open for the detinue to choose her own way of life.
