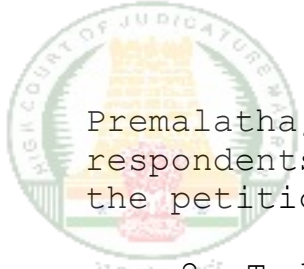

One M.Karthikumaran, the petitioner herein has filed this Habeas Corpus Petition stating that his wife, namely, Mercedes



Premalatha, aged 21 years, has been taken illegally by the respondents 3 and 4. Therefore, a complaint has been preferred by the petitioner before the respondent police on 05.09.2016.

2. Today, when the matter was taken up for hearing today, the parents, namely, the respondents 3 and 4, themselves, have produced the detainee, namely, Mercedes Premalatha. On our enquiry, she told that she is willing to go with her husband, namely, the petitioner. On further enquiry, she stated that on 14.01.2016, marriage was performed between the petitioner and the detainee and now, she is pregnant. When we enquired the parents of the detainee, they are also willing to send the detainee with the petitioner herein.

3. In such view of the matter, recording the submission of the detainee, this petition is closed by giving liberty to the detainee to choose her own way of life.
