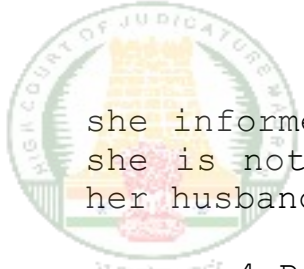
ORDER

The petitioner is the mother of the detainee, namely, P.Poomanimala, aged about 19 years. It is alleged that the detainee had been found missing from 17.08.2016. Despite complaint, the detainee has not been secured and therefore, the petitioner is before this Court with this petition.
