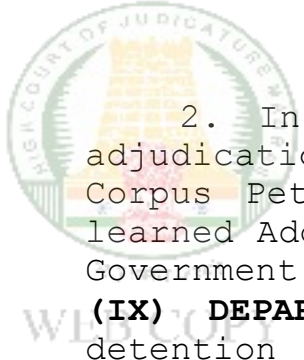

ORDER
