The petitioner has come up with this Public Interest Litigation seeking a direction to the 2nd respondent to provide drinking water facility to all houses in Ward Nos.1 to 33 in Kadayanallur Municipality, as per Section 129 of the Tamil Nadu District Municipalities Act, 1920.

When the matter was taken up for hearing, the learned Government Advocate appearing for the first respondent, on instructions, would submit that as directed by the first respondent, the second respondent is taking steps to provide drinking water supply to all the houses following the procedure established by law. The said statement is recorded.
