Vide order dated 24.03.2010, in W.P.(MD)No.3886 of 2010, the writ petitioner has been directed to be included in the panel of Assistant Director in Local Audit Fund Department for the year 2009-2010, if there was no other legal impediment. The said exercise has to be done within a period of four weeks from the date of receipt of a copy of the order made in the writ petition.

2.On this day, when the matter came up for hearing, on instructions, Mr.AK.Bhaskarapandian, learned Special Government Pleader submitted that subsequently, the writ petitioner has been promoted as Assistant Director and later on he has also retired from service.

3.In view of the above, nothing survives in this writ appeal for further adjudication. Hence, the writ appeal is dismissed. No costs. Consequently, connected CMP is also dismissed.
