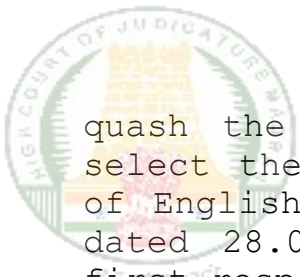

JUDGMENT

On this day, when the matter came up for hearing, Mr.D.Shanmugaraja Sethupathy, learned counsel appearing for the first respondent submitted that pursuant to the directions granted by the writ Court, M.A. degree in English and Communicative Studies, offered by Gandhigram Rural Institute Deemed University has been made equivalent as M.A. degree in English and orders have been issued by the Government in G.O.Ms.No.72, Higher Education (K2) Department, dated 30.04.2013 and thereafter, vide order in Na.Ka.No.97608/பி.என்.டி.3/2013, dated 02.12.2013, the first respondent has been appointed as Post Graduate Assistant.

2.Added further, Mr.VR.Shanmuganathan, learned Special Government Pleader submitted that in other identical matters, orders of appointment has been issued to the eligible candidates.

3.Copy of the proceedings in Na.Ka.No.97608/பி.என்.டி.3/2013, dated 02.12.2013, issued by the Joint Director (Higher Secondary), School Education Department, Chennai, produced before this Court, is treated as part of record.

4.In view of the above submission, nothing survives in this writ appeal for further adjudication. Hence, the writ appeal is dismissed. No costs. Consequently, connected Miscellaneous Petition is also dismissed.
