Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a Writ of Certiorarified Mandamus, call for the records pertaining the impugned selection list dated 05.12.2012 relating to the petitioner and quash the same and consequently direct the second respondent to select the petitioner for the post of Graduate Assistant (B.T. Assistant) in the discipline of B.A. English vacancy arising out of the Tamil Nadu Teacher Eligibility Test - Supplementary 2012 held 14.10.2012 and direct the second respondent to appoint her in the above Post.

Prayer in WP(MD). 16073/ 2012 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a Writ of Certiorarified Mandamus, call for the records pertaining to the impugned selection list dated 05.12.2012 relating to the petitioner and quash the same and consequently direct the second respondent to select the petitioner for the post of Graduate Assistant (B.T Assistant) in the discipline of B.A English vacancy arising out of the Tamil Nadu Teacher Eligibility Test - Supplementary 2012 held on 14.10.2012 and direct the second respondent to appoint her in the above post and pass such other appropriate order.



Prayer in WP(MD). 16096/ 2012 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a Writ of Certiorarified Mandamus calling for the records relating to the Impugned Order published in the internet (Social Media) on 05.12.2012, of the 1st respondent rejecting the candidature of the petitioner to the post of Graduate Teacher (BT Assistant) in the subject of English and to quash the same and consequently direct the respondents to issue appointment order for the post of Graduate Teacher (BT Assistant) in accordance with the communal rotation and the priority laid down by the Govt. of Tamil Nadu.
