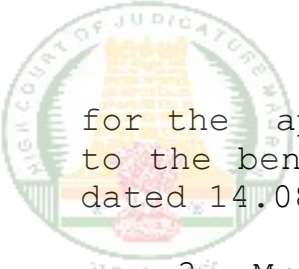
JUDGMENT
