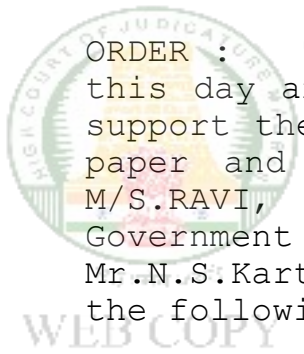

Writ Miscellaneous Petition filed under Article 226 of the Constitution of India, praying that in the circumstances stated therein and in the affidavit filed thereof the High Court will be pleased to restore the Writ Petition No.6992 of 2008 which was dismissed for default on date 10/06/16.

Prayer in WP(MD). 6992/ 2008 :

Writ Petition is filed under Article 226 of the Constitution of India, to issue a writ of Certiorarified Mandamus or any other appropriate writ Direction or order in the nature of a writ, calling for the records relating to the orders in (1) Pro.Rc.No.TP2/1320/2007 dated 23.8.2007 of the second respondent (2) Na.Ka.No.19295/2005/C1 (MAIYAM) dated 6.6.2007 of the fourth Respondent and (3) Letter No. 29378/Ma.Na.5/2007-2, municipal Administration and Water supply Department, dated 24.3.2008 on the Ist respondent and to quash the same and to issue consequential directions to the Respondents to reinstate the petitioner in service and then regularise her services in the post of Clerk / Junior Assistant from the date of her initial appointment and to absorb her in a regular post in the Tiruchirapalli City Municipal Corporation and to grant consequential service and monetary benefits.



ORDER : This Writ Miscellaneous petition coming on for hearing on this day and upon perusing the petition and the affidavit filed in support thereof the order of the High Court dt.10.6.16 and material paper and upon hearing the arguments of M/s.S.Porkodikarnan for M/S.RAVI, Advocate for the petitioner and of Mr.M.Murugan, Government Advocate on behalf of the Respondents 1 to 3 and Mr.N.S.Karthikeyan, Advocate for the respondent No.4, the court made the following order:-

"Heard the learned counsel for the petitioner, learned Government Advocate as well as the learned counsel appeared on behalf of Tiruchirappalli City Municipal Corporation.

The petitioner in her affidavit filed in support of the application indicated the sessions for her absence on 10.06.2016.
