In view of the above submission made by the learned counsel for the petitioner, the second respondent herein is directed to dispose of the representation of the petitioner, dated 29.4.2016, in the light of G.O.Ms.No.61, Transport (C) Department, dated 30.04.2015 and the settlement signed under Section 12(3) of the Industrial Disputes Act, dated 22.01.2011, within a period of four weeks from the date of receipt of a copy of this order.
