4.The learned counsel appearing for the petitioner would submit that the petitioner has given a representation to the



respondent on 15.07.2016 to get permission and protection to conduct Cricket matches, but the same was not considered by the respondent so far and hence, the petitioner is before this Court with this writ petition.

5.The learned Additional Government Pleader appearing for the respondent would submit that appropriate conditions have to be imposed while granting permission.

6.Under such circumstances, the respondent is directed to consider the representation of the petitioner dated 15.07.2016 and to impose appropriate conditions while granting permission.

7.The Writ Petition is disposed of with the above direction. No costs.
