5.The learned Additional Government Pleader, on instructions, would submit that the respondent may be directed to consider the representation of the petitioner.

6. In view of the above, the respondent is directed to consider the representation of the petitioner and dispose of the same within a period of three days from today, as the demonstration is scheduled to be conducted on 31.07.2016.
