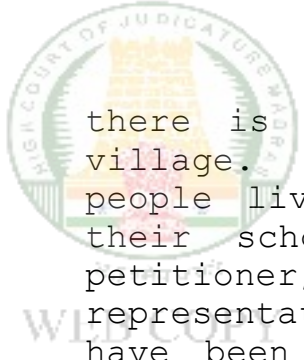

Due to the same, the school going children and the people living in that area have to walk several kilometres to their schools and respective places. In this regard, the petitioner, who is the Ward member of that locality, has given a representation to the respondents on 15.02.2016. Since no steps have been taken on the said representation, the petitioner is before this Court with this writ petition.

4. In view of the above, we direct the respondents, namely, the 1st respondent District Collector, Tuticorin District, to take steps on the representation given by the petitioner dated 15.02.2016 and pass appropriate orders within 12 weeks from the date of receipt of a copy of this order.

With the above direction, this writ petition is disposed of. No costs.
