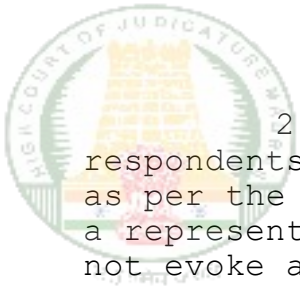

No.4829 of 2016, dated 10.03.2016**, has directed the respondents therein to consider the representations of the petitioners therein. Therefore, he submitted that similar directions may be issued to these petitioners also.

In view of the above, the respondents are directed to consider the representation of the petitioner, on merits and in accordance with law, and pass appropriate orders, within a period of four weeks from the date of receipt of a copy of this order. The petitioner is also directed to enclose a copy of this order along with the representation already sent to the respondents, for further follow up, in this regard.
