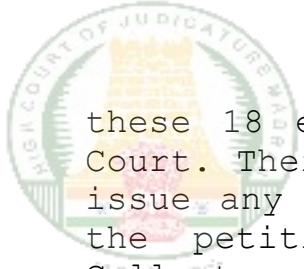
ORDER

It is for the petitioner to work out his remedy before the District Collector or the authority concerned for removal of encroachments.
