5.The learned Additional Government Pleader appearing for the respondent undertakes to consider the representation of the petitioner dated 04.08.2016 and pass orders.

6.In view of the above submission, the respondent is directed to consider the representation of the petitioner dated 04.08.2016 and pass suitable orders thereon on or before 18.08.2016 on merits and in accordance with law.

7.With the above direction, the Writ Petition is disposed of. No costs.
