but, however, the same was not considered by the respondents so far and hence, the petitioner is before this Court with this writ petition.

4. The learned Additional Government Pleader for the respondents would submit that the representation of the petitioner dated 24.08.2016 will be considered and suitable orders will be passed thereon.

5. Once a representation has been received by the respondents, it is their bounden duty to decide on the same. Therefore, the 2nd respondent is directed to consider the representation of the petitioner dated 24.08.2016 and pass appropriate orders thereon on merits and in accordance with law, on or before, 04.09.2016.
