O R D E R

This writ petition has been filed, seeking a direction to the respondent to grant permission and protection for Gramia Nadanam, Innisai Kacheri and other programmes scheduled to be held on 01.10.2016 to 05.10.2016 in Arulmigu Sri Muppudathi Amman Kovil situated at Silavarkulam, Alangulam Taluk, Tirunelveli District, by considering the petitioner's representation, dated 25.08.2016.

2. Learned counsel for the petitioner would submit that the villagers jointly decided to perform the cultural event in Arulmigu Sri Muppudathi Amman Kovil situated at Silavarkulam, Alangulam Taluk, Tirunelveli District, scheduled to be held on 01.10.2016 to 05.10.2016. He would further submit that in this connection, a representation was given to the respondent police on 25.08.2016, with a request to grant permission to conduct the programme on the above said dates. However, the respondent Police has not yet considered the said representation and hence, the petitioner is before this Court with this Writ Petition.



3. Heard the learned Government Advocate for the respondent.

4. In view of the limited scope of prayer sought for in this petition, the respondent police is directed to pass orders in accordance with law either permitting or rejecting the representation, dated 25.08.2016, given by the petitioner, taking into account the law and order problem and other aspects, prevailing in the area, well before the date of function.

5. With the above direction, this Writ Petition is disposed of. No costs.
