Furthermore, as rightly pointed out by the learned Counsel for the respondents, even if the petitioner is aggrieved by the order, he is always at liberty to prefer necessary appeal against that order in the manner known to law, if he desires to do so and the petitioner is directed to file an appeal within ten days from the date of receipt of a copy of this order.

5. With the above direction, this Writ Petition stands closed. Further, it is made clear that in case, if the petitioner prefers an appeal, the respondents shall exclude the time of litigation spent for this Writ Petition in this Court, for the purpose of limitation. No costs. Consequently, the connected miscellaneous petition is closed.
