Prayer: Writ Petition is filed under Article 226 of the Constitution of India praying for the issuance of a Writ of Certiorarified Mandamus calling for the entire records pertaining to the ex-parte impugned order passed by the 1st respondent vide his proceedings in Pa.Mu.No.12557/N4/2016, dated 25.04.2016 and the consequential memo issued by the 3rd respondent in C.Pa.No.124/09 signed on 30.06.2016 and quash the same and further direct the 1st respondent to dispose of the petitioner's appeal paper, dated 29.08.2013 and pass speaking order by giving reasonable opportunity to him without considering the delay.
