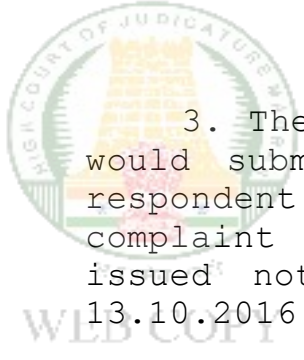

Considering the nature of prayer sought for in this Writ Petition and the submission made by the learned Government Advocate (Crl.Side), the second respondent shall dispose of the representation made by the petitioner dated 29.08.2016 on merits and in accordance with law, without taking note of the closure of earlier complaints, within a period of eight weeks from the date of receipt of a copy of this order.

5. Accordingly, this Writ Petition is disposed of. No costs. Consequently, the connected Miscellaneous Petition is closed.
