The petitioner has sent a representation dated 11.01.2016 to the second respondent to grant appointment order. As the same has not been considered so far, the present writ petition has been filed.

4.It is agreeable for the respondents to consider the representation of the petitioner dated 11.01.2016 and to pass orders.

5.Accordingly, the second respondent is directed to consider the representation of the petitioner dated 11.01.2016 and to pass orders on merits and in accordance with law within a period of four weeks from the date of receipt of a copy of this order.

6.The Writ Petition is disposed of with the above direction. No costs.
