2.By consent, the Writ Petition itself is taken up for final disposal.

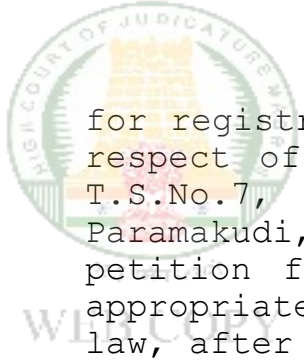
