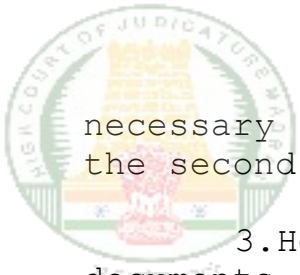

ORDER

The petitioner has filed this Writ Petition seeking a direction, directing the 2nd Respondent herein to measure the house property of the petitioner in Survey No. 25/4B in Kurukusalai Panchayat, Ottapidaram Taluk as per registered sale deed dated 02.08.1972 based on the petitioner's representation dated 01.04.2016.

2.According to the petitioner, he has filed an application before the second and third respondents on 01.04.2016 to survey her land and demarcate the boundaries and she has also paid



necessary fees for the same. Sofar, no action has been taken by the second respondent.

3. Heard the submissions made on either side and perused the documents carefully.
