Petition filed under Article 226 of the Constitution of India, praying for the issuance of a Writ of Mandamus, directing the Respondents to revise the petitioner's pay in the Post of Checking Inspector with retrospective effect from 27.10.2012 in terms of Government Order in G.O.Ms.No.61, Transport (C) Department, dated 30.04.2015 and as per settlement dated 13.04.2015 and further directing the respondents to pay him the difference amount in his salary from 27.10.2012 to 30.06.2014 and to pay difference in his retirement benefits including difference amount in monthly pension, gratuity, leave salary, commuted value of pension and all other attendant benefits payable to him from 01.07.2014 to till date together with interest at the rate of 18% per annum.

ORDER

The petitioner was employed as Checking Inspector in the respondents Transport Corporation; he retired from service on 30.06.2014; his grievance is that he is entitled to revision of scale of pay as per G.O.Ms.No.61, Transport (C) Department, dated 30.04.2015 and also as per the Settlement dated 13.04.2015; since his pay was not revised, he made a representation dated 08.01.2016 therefor; that representation was not considered and therefore, the petitioner has sought for this Writ of Mandamus, directing the respondents to revise his pay in the post of Checking Inspector with retrospective effect from 27.10.2012 in terms of G.O.Ms.No.61, Transport (C) Department, dated 30.04.2015 and as per settlement dated 13.04.2015 and further directing the respondents to pay him the difference amount in his salary from 27.10.2012 to 30.06.2014 and to pay difference in his retirement benefits including difference amount in monthly pension, gratuity, leave salary, commuted value of pension and all other attendant benefits payable to him from 01.07.2014 to till date together with interest at the rate of 18% per annum.

2.Learned counsels for the respondents submitted that it is agreeable for the respondents to consider the representation of the petitioner dated 08.01.2016 and to pass orders.

3.Recording the above submission, this Writ Petition is disposed of directing the respondents to consider the representation of the petitioner dated 08.01.2016, in the light of G.O.Ms.No.61, Transport (C) Department, dated 30.04.2015 and also as per the Settlement dated 13.04.2015 and to pass appropriate orders on merits and in accordance with law, within a period of four weeks from the date of receipt of a copy of this order. No costs.

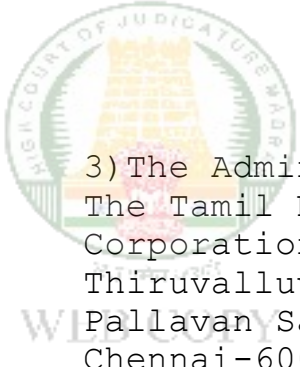
