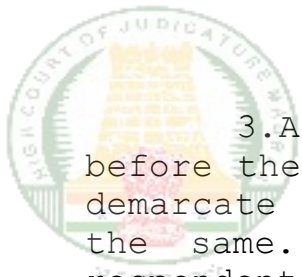

Since the petitioner filed necessary application, dated 11.07.2016 along with necessary fee and that is pending, the second respondent is directed to conduct survey of petitioner's land in Survey No.845/1, Puliyurnatham Village, Oddanchatram Taluk, Dindigul District with the help of surveyor and pass orders on merits and in accordance with law, after issuing notice to the petitioner as well as the neighbouring land owners, with reference to the revenue records and the petitioner's title deeds, within a period of 8 weeks from the date of receipt of a copy of this order.

6. With the above direction, this writ petition is disposed of. There shall be no order as to costs.
