PRAYER: Writ Petition is filed under Article 226 of the Constitution of India praying to issue a Writ of Mandamus directing the 1st Respondent to pay the petitioner Rs.5,75,864/- towards Gratuity and Rs.2,86,934/- towards Leave Salary, together with 18% interest per annum along with interest amounts towards the delayed payment of EPF Employees Contribution amount Rs.1,93,575/- for the period from 30.09.13 to 20.01.14 and towards the delayed payment of Employees Social Security Scheme Benefit amount Rs.41,525/- for the period from 30.09.13 to 20.04.15 at the rate of 18% p.a. and further directing the 1st and 2nd respondents to pay him interest amount towards the delayed payment of Pension Commutation amount Rs.2,51,331/- for the period from 01.10.13 to 19.02.14 and arrears of pension for the period from 01.10.13 by revision his pension, together with 18% per annum after calculating all his terminal/pension benefits based on the monthly wages payable to him on the month of his retirement, i.e., September, 2013 by revising the same as per the settlement dated 13.04.15, as ordered by the Division Bench of this Court in its order dated 29.01.16 in W.A(MD)No.1457/15 and etc., batch.

<https://hcservices.elsegovt.in/hcservices> The petitioner was employed as Special Grade Assistant in the respondent Corporation and he retired from service on 30.09.2013 on reaching the age of superannuation.



2.He has filed this writ petition seeking for a direction to the respondents to pay the retirement benefits.

3.The First Bench of this Court in similar matter has passed an order dated 12.06.2015 in W.A.(MD)Nos.383 to 457 of 2015, issuing direction to the transport Corporations to settle the terminal benefits of its employees in equal monthly installments and to pay 6% interest on the terminal benefits payable to the workman. The Bench has also held that workman is entitled to 18% interest for the defaulted period of installments.

4.In these circumstances, this writ petition is disposed of with the following directions:-

i)A direction is issued to the transport corporation to settle the terminal benefits of the petitioner that are yet to be settled, in twelve equal monthly installments;

ii)The first installment shall commence by making payment on or before the First Week of December, 2016 and the amount in each of the remaining installments shall be paid on or before 10th of every succeeding month;

iii)The said terminal amount shall carry interest @ 6% per annum, as per the Division Bench judgment referred to above. In case of delay in making installments, the interest payable could be 18% for the delayed period;

iv)The aforesaid direction to settle the terminal benefits would not preclude the workman to question the computation of any of the terminal benefits, if the same is paid lesser than the amount to which, he is entitled to receive. Likewise, if the petitioner has any grievance that he is entitled to interest for the amount already settled, he can agitate the same as per law, if he is entitled. No costs.
