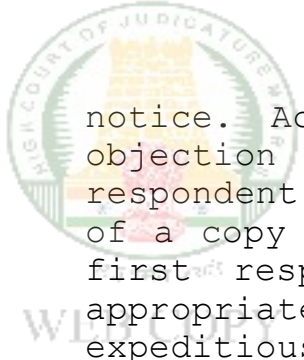
ORDER

Accordingly, the petitioner is directed to submit her objection before the first respondent as directed by the first respondent within a period of two weeks from the date of receipt of a copy of this order. On receipt of such representation, the first respondent is directed to consider the same and pass appropriate orders after giving opportunity to the petitioner as expeditiously as possible.

4. Accordingly, the writ petition is dismissed. No costs. Consequently, W.M.P(MD)No.14751 of 2016 is closed.
