Considering the facts and circumstances and without going into the merits of the case, the second respondent is directed to consider the application filed by the petitioner on 02.03.2015 and pass appropriate orders on merits and in accordance with law, within a period of four weeks from the date of receipt of a copy of this order, after giving notice to the petitioner as well as to the rival claimants if any, with reference to the revenue records and the petitioner's title deeds.

5. With the above direction, the writ petition is disposed of. No costs.
