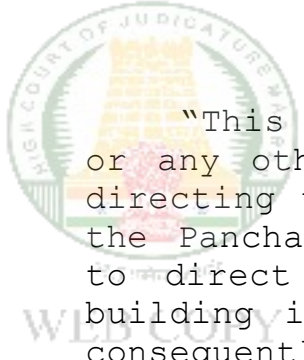

When the matter was taken up for hearing today, the learned Government Advocate appearing for the official respondents submitted that the construction of compound wall in the said school has already been commenced by the second respondent and thus, nothing survives in this Writ Petition. The said submission is recorded.

3. In view of the above, this Writ Petition is dismissed as infructuous. No costs.
