The petitioner has come up with this Public Interest Petition seeking to quash the proceeding of the first respondent in Na.Ka.C4/12452/2014, dated 18.06.2016 and to direct the respondents to construct the school building in Survey No.262, (New Survey No.285) in Mangulam Village, Manamadurai Taluk, Sivagangai District.

2.Today, when the matter was taken up for hearing, the learned Special Government Pleader submitted that near the existing school building, a Government land had been assigned for the purpose of constructing additional building for the school and subsequently, tender was called for, the contract was awarded and the construction has already been commenced. The said statement is recorded.

3.In view of the above, nothing survives for adjudication in this petition. This Writ Petition is, therefore, dismissed. No costs. Consequently, connected miscellaneous petitions are also dismissed.
