2.According to the petitioner, he is residing in Door No.197-B, Kavarayapatty, Reddiyapatti Panchayat, Natham Taluk, Dindigul District, Aathar card was also issued to him and his name is also found place in the voters' list. In the above said circumstances, he has filed an application before the second respondent/Taluk Supplies Officer, Natham Taluk, Dindigul District to issue a Ration Card on 16.09.2016. Sofar, no order has been passed. Hence, he has filed the present writ petition.



3. Heard the learned Government Advocate appearing for the respondent, who would submit, on instructions that the petitioner's application would be considered.
